2023/136 Approval of Minutes

To confirm the Minutes of the Council Meeting held 21st February 2024. The minutes were APPROVED, and it was <u>RESOLVED</u> that the minutes be signed and ADOPTED as a true record. Proposed by Cllr Hilder & seconded by Cllr Parkhill. Minutes signed by the Chairman.

2023/137 Clerks Report

- 1) Bus Shelter The damage on the bus shelter has got worse, and now a third panel is damaged too. How do we combat this? The suggestion of would a wooden structure be more suitable was put forward, however it was reminded that the reason for the current design is for protection from the weather, but with the ability to be able to see the bus coming. The claim has gone to the insurance company for the 2 panels and another claim will now need to be made for the third.
- 2) Quarry complaint Clerk has confirmed that the ongoing complaint is the one for noise, dust etc.. Clerk will chase contact at the council for an update.
- 3) The Lengthsmen has been in contact with Shropshire Highways, who have been out to meet with him and discussed the areas of flooding around the parish and the use of the jetting machine.
- 4) The residents with the over hanging hedge have been contacted.
- 5) Pot holes The council have been out and started to fill in the pot holes. The ones with natural springs have been left until the drier weather.

2023/138 Parish Matters

- 1) Waste Management There has been a few more meetings, locally, without representation of the county council regarding the waste management issue on Lion Lane. Shropshire Council/Veolia are sending a little lorry down for the most vulnerable residents, but not for all. Overall, Shropshire Council's stance stays the same, that until the residents repair the unadopted road, Veolia will not be going down there to collect the waste.
- 2) Barking Dogs it has been reported that there are dogs barking throughout the day and night within the parish. This is extremely disruptive and therefore the residents in question will be contacted.
- 3) Council Bill Coreley Parish Council agreed that the precept would be increased by 4.99% for the 24/25 financial tax year, however the Council Tax bills that have been received by residents state 6.2%. Clerk will contact Shropshire Council for an explanation.
- 4) Mattress There has been a mattress dumped in a gateway, by the Rectory. Clerk to contact Shropshire Council to remove.
